If there is any question regarding my medical fitness, I agree to seek medical consultation before I volunteer. In case of emergency, I hereby grant permission to the medical provider to secure proper treatment, including hospitalization, anesthesia, surgery, or injections of medication for me or my child and to provide protected health/medical information to the health care provider.

On my behalf and on behalf of my child, I hereby fully release and discharge Operation 9-2-99 Tuolumne River Project, and the County of Stanislaus, their respective employees, property owners and other volunteers (the "Rereleased Parties") from any and all claims for any injuries, death or losses I suffer that are related in any way to my volunteering for Operation 9-2-99 Tuolumne River Project.

I fully understand this is a RELEASE OF LIABILITY and that I am GIVING UP MY RIGHT TO SUE the Released Parties for any injury or losses suffered as a result of my volunteering for Operation 9-2-99 Tuolumne River Project.
